2. 2026 Memberships purchased after March 1, 2026 must meet all of the following:
  - a. Documentation of a serious illness or injury from medical doctor is submitted to the Director of Golf no more than 60 days from date of membership purchase.
  - b. Refund requests made after June 30, 2026 will not be honored.
  - c. No more than three (3) rounds of golf are played between March 1, 2026 and time of refund request. Equivalent greens fee(s) will be deducted from Membership Fee prior to approved refund.

The lessee also agrees that no right of action shall accrue to the lessee for any loss or damage to person or property arising from the use of the cart or resulting from any mechanical failure or component of the said cart. The lessee further agrees to hold Dennis Golf free and harmless against all claims arising from the operation of the said cart. The lessee shall assume the entire responsibility of loss or damage to cart, person or property caused by a guest passenger.
